

Fixed Issues and Enhancements

Web GUI Changes

Enh	ancement	Description
1.	Report TRN03 Missing "buckets" for transaction types	 Fixed The TRN03 [Voided Transactions Totals] report was incorrectly missing transaction type 'buckets'. This has been corrected and the missing types have been added to the report.
2.	PNG image color correction	 Fixed PNG images created with GIMP have color correction information that can sometimes cause rendering differences in different browsers.
3.	Deleted or Invisible groups issues	 Fixed Corrected an issue where deleted or invisible groups caused user management issues to occur.
4.	Corrected ConMan login failure	 Fixed Corrected an issue where reporting on the Set locked status of a user caused errors when logged into certain companies using the Configuration Manager.
5.	When editing a user, Permission Level will be set correctly	 Fixed Corrected an issue where, when editing a user, their "Permission Level" would be set to the first permission level instead of their current permission level, which could result in an unintended change of permission level. This has been corrected so that the user's current permission level is displayed.
6.	Add setting to allow Transaction Export older than 7 days	 Enhancement A new setting has been added that can be configured to allow given merchants the ability to temporarily retrieve a Transaction Export that is more than 7 days old. This value can be updated by support; any merchant in need of an export older than 7 days will need to contact support to enable this option temporarily.

Enhancement	Description
Scheduled reports failing for some users	 Fixed Scheduled reports were not being properly generated for users other than Root Administrators, or users that had All Store Access. This has been corrected so that Scheduled reports are now generated properly for all users.
8. Alerting can send emails with no alerts on the daily summary	 Fixed Corrected an issue where a an alert generated by a store that has been configured, but never sent up a status message (Silent Store) would cause an alert e-mail to be triggered, even if that e-mail would contain no alert data. This has been corrected so that Silent Stores no longer trigger e-mail alerts.
9. IE9 report printing issue	 Fixed Corrected an issue with the RSPrintControl that prevented users running Internet Explorer 9 from successfully printing reports.
10. Error when using a Management Company for the first time	 Fixed Corrected an error that occurred when using a Management Company for the first time.
11. Eliminate Views from Reporting	 Enhancement To eliminate inefficient views, multiple reports have been rewritten. The following reports have been revised: SSR01 [Store Sales Summary] SSR02 [Store Sales Summary by Store and Lane] SSR03 [Store Sales Summary by Store and Cashier] SSR04 [Store Sales Summary by Store] TRN10 [Pre-Auth / Pre-Auth Completion]
12. Revise Report Control	 Enhancement The report control has been revised to no longer rely on ActiveX, so that ActiveX updates no longer interfere with reporting.

13. Remove Summary Amount from TRX03 export	 Fixed The Summary Amount column has been removed from the TRX03 report export.
14. Reconfiguring a report with dates specified caused an error	 Fixed Corrected an issue where if dates were specified when generating a report, the configuration screen could generate an error and fail.
15. TRN10 Report - Completions missing from the Pre-auth / Auth Completion Report	 Fixed On the TRN10 [Pre-Auth / Pre-Auth Completion] Report, Completions were incorrectly missing from the transaction list, even though the Transaction Count and Amount Totals were correct. This has been fixed so that Completions are properly displayed.
16. Pre-auth/ Completion Report (TRN10) incorrect Total Amount	 Fixed Corrected an issue that could cause the Total Amount in TRN10 [Pre-Auth / Pre-Auth Completion] report to be incorrect. Fixed
17. Transactions not calculated into the transaction details/totals	 Corrected an issue where the SSR02 [Store Sales Summary by Store and Lane] report treated lane number prefixed by a "0" as different from those without a leading "0" (.i.e. "01" vs. "1"). This has been corrected so that leading zeros are ignored when calculating transactions and totals for reporting.
18. Transactions not calculated into the transaction details/totals	Corrected an issue where the SSR03 [Store Sales Summary by Store and Cashier] report treated lane number prefixed by a "0" as different from those without a leading "0" (.i.e. "01" vs. "1"). This has been corrected so that leading zeros are ignored when calculating transactions and totals for reporting.
20. Store Group details lists are blank	 Fixed Fixed an issue where a user whose store access has just been modified could incorrectly see a blank list of stores instead of the list of stores they should have access to.

21. New Retalix Logo	 Enhancement ServerEps & ConnectedPayments Web Clients have been updated with the new Retalix logo and kaleidoscope image.
	The StoreNext logo has been replaced with the new Retalix logo on the ConnectedPayments site.
22. Silverlight ConMan launch page updates	 Enhancement The Silverlight Configuration Manager page has been updated to launch maximized, if supported by the web browser, and to have a 1024x768 minimum size. The Preview Image has been updated to match its new look.
23. Add permission setting to create report subscriptions	 Enhancement Added user permission to determine if report subscriptions are allowed. By Default this option will be "Allowed", but that may be modified by users with the appropriate permissions.

This was not being correctly indicated on the outgoing message to the Chase host, where instead it was indicated that the PAN was taken from Track 1. This has been corrected to properly indicate that the PAN is taken from Track 2.
3. Write AVS and CVV2 results from host response to database	 Enhancement AVS and CVV2 results from the Chase host are now written to database.
4. Host Spec update (v3.13.3)	 Update The Chase Paymentech Host interface has been updated to comply with the latest Chase specification, v3.13.3.
5. Send Customer Number as AAA Member Number	 Enhancement A customer's AAA Member Number is now sent to the Chase host in the Custom Data Field, based on the Customer Number provided by OpenEPS.
